AlLedgeTM also features a line of add-on modules including LetterMakerTM, CollectTM, RecallTM, ReferTM, and AppointTM.

All services for which you can bill the doctor.

For each claim submitted electronically from one of your AcClaim from ICSTM placements, you will receive a royalty of up to 28% on the 69¢ per claim fee collected from the practice.

Electronic Claims Fees - Each month, you bill the doctor an amount - determined by you - for each claim transmitted. ICS bills you the transmission fee for each claim submitted. The difference is your gross profit.
